On 11/24/12, a Sobriety Checkpoint Deployment was conducted by the Pima County Sheriff's Department (PCSD) in the vicinity of 8500 North Oracle Road.

The Driving Under the Influence (DUI) Unit supervisor, Sergeant J. C. Dowdy #1349, planned the operation and conducted an informational briefing for personnel participating in the deployment. The briefing took place at the PCSD SOC room at 1750 East Benson Highway. The informational briefing was delivered via Power Point by Sergeant Dowdy. Once all participating personnel were given their assignments, completed and signed, as well as turned in their sobriety checkpoint briefing checklists, all involved traveled to the checkpoint location for setup.

The checkpoint became operational at approximately 2100 hours and lasted until 0055 hours. During this time, 1,754 vehicles passed through the sobriety checkpoint. 21 standardized field sobriety tests (FST) were conducted, which resulted in the arrests of four subjects, one of which was also arrested for possession of marijuana.

During the checkpoint, the east and westbound lanes were open due to traffic from 2130 hours to 2136 hours, after which time the checkpoint did resume. At 2215 hours until 2220 hours, the westbound lane was open due to traffic backup. The checkpoint resumed until it concluded at 0055 hours.

This concludes my involvement.
