Initial Case Narrative by W. V. Harris #6714 on 12/15/12 at 2215 hrs.

On 12/15/12, a Sobriety Checkpoint was conducted on La Canada Road just south of Duval Mine Road. Sergeant J. C. Dowdy #1349 of the Driving Under the Influence (DUI) Unit planned the operation and conducted an informational briefing for personnel participating in the deployment.

The briefing took place at 601 North La Canada Drive at the Green Valley District Office. The informational briefing was delivered via PowerPoint by Sergeant Dowdy.

Once all participating personnel were given their assignments, completed and signed, as well as turned in their Sobriety Checkpoint briefing checklist, they traveled to the checkpoint location for setup.

The checkpoint became operational at approximately 1915 hours and ended at approximately 2100 hours. During that time, 281 vehicles passed through the sobriety checkpoint, four subject were directed to perform standardized field sobriety tests (FST). There were no arrests made at this checkpoint.

Due to the lack of vehicular traffic passing through the checkpoint at approximately 1930 hours, Sergeant Dowdy dismissed the following deputies to perform Saturation Patrol in the area of the checkpoint. Those deputies were:

After the checkpoint was completed, Saturation Patrol was conducted in both the San Xavier and the Foothills Districts.
